- 1. Pledge / Call to Order / Roll Call
- 2. Public Hearing LL 1 of 2023- Code Enforcement Law

#### Minutes:

Jeffrey Horton opened the Public Hearing on Local Law 1 of 2023 at 7:01 PM and explained that the Local Law # 1 of 2023 is a law that the State has written and passed down to Towns. This law is mandatory for Towns to adopt. If the Town does not adopt the Law, they will not be able to enforce Code Law. Supervisor Horton asked if there were questions or comments from the Public. Norm Maynard questioned if this was a new law. Denice Thompson questioned if the new law would give specifics on what needs to be done for new electric installation. Dale Seeley questioned how the new law related to Zoning laws already in place.

Thomas Hargrave explained that The law is being put into place because the State wants all code law to be uniform. The new law will not give specifics on new electrical installations, NYSEG will not turn on a new service unless there has been a third party inspection. Zoning and Code Law are intertwined. With no further questions Supervisor Horton closed the Public Hearing at 7:12 PM.

Resolution 1 of 2023 to adopt LL#1 of 2023was made by John Tschantre and seconded by James Drumm as follows: BE IT RESOLVED AS FOLLOWS:

- 1. That the Town Board of the Town of Campbell accepts and proposes to adopt a local law to be designated as Introductory Local Law No. 1 of 2023 entitled the "Building Construction and Fire Prevention Law of the Town" to protect the health, safety and well-being of persons and property and to incorporate the requirements in amended Part 1203 of Title 19 of the New York Codes, Rules and Regulations and that a copy of the proposed revised local law is annexed hereto and incorporated into this resolution as though set out in full.
- 2. That a public hearing be held on February 13, 2023, at 7 P.M. at the Town Hall 8529 Main Street, Campbell, New York.
- 3. That the Town Clerk, with the assistance of the Town Attorney if requested, is directed to prepare the legal notice required to be published and to provide such notice for timely

publication in the official newspaper.

4. That a copy of such legal notice be posted upon the Town Clerk's bulletin board and Town website as required by law.

Following discussion, the foregoing resolution was called to a vote which resulted as follows:
