# 2. Troop 79 Eagle Scout Projects

# Minutes:

Jeffrey Horton invited the two Eagle Scouts from Troop 79 in Painted Post, who were, in attendance to share their proposed projects. Brenden Jordin-Reed would like to build 4 benches for the players to use during the games. The Benches would be made of wood and would be moveable. He would also like to repair the benches that are currently there. The materials would be purchased with money raised from fundraising. Michael Austin questioned if the benches would be painted or stained- John Tschantre suggested stain instead of paint. Thomas Austin said it would be a good project- the Board agreed. Alex Jordin-Reed proposed building a scoreboard for the various games. It would be made from 6x6 posts and set 3' into the ground with concrete- no electricity. The numbers and the materials would be purchased with money raised from fundraising. Michael Austin group raised from fundraising. Michael Austin suggested that Alex buy bags of concrete and pour it into the hole with the posts. The Board agreed that this would be a good project. Jeffrey Horton let the young men know to let the Town know what they would need from the Board.

#### 4. Reports

#### a. HWY / Water Report

#### Minutes:

Thomas Austin recently attended the Highway Superintendent Conference in Syracuse. There are several changes being proposed in the Hudson Valley area that may affect the rest of the state. There is a push to lower the salt consumption for the roads, or move to using another substance such as sand. The cost of the change would be very high. Michael Austin asked if this would be a law or mandate? Thomas Austin said that he was not sure, but like other changes made in the Hudson Valley, they would migrate to our area. Michael Austin questioned whether Towns would have to go to electric vehicles for their Highway Departments. There is no new news on the electric vehicle front, but at this time it is not feasible for small towns.

Water- We are able to connect from the main by Tim Cole's house by the railroad tracks to the new meter pit. Which dead-ended the fire hydrant near the railroad tracks. That hydrant will be removed, and the valve given back to Tom Austin for spare parts. A new hydrant was placed and passed all pressure tests. Yard work will begin in the spring to allow for settling ground. Denice Thompson asked when people can begin to hook up, and how late can they hook up this year. Thomas Austin said the lateness of hookups will depend on the weather. As long as the contractor can break ground safely. Norm Maynard asked if money was being held back from the bills until the project is completed. Thomas Austin confirmed that 5% of each bill was being held back.
