The State of NY is making it easy for you to get out to VOTE this November. **Come out and VOTE November 3rd at your designated polling place here at the Town Hall or at the East Campbell Fire Hall from 6 am – 9 pm.** Also, there have been a few changes that may help you avoid the crowds. First, anyone can get an absentee ballot sent to their home or vacation destination. **Absentee ballot forms and new voter registration forms are available at the Town Hall.** Second, NY residents will have the option of **Early Voting again this year beginning October 24, 2020 and running through November 1, 2020, at the new**

Steuben County Annex building located at 20 E. Morris Street in Bath NY.

Due to COVID-19 the Revaluation Project for 2020 was extended to 2021.

Revaluation Project Update

2021- I will be reviewing all properties in the town through

the month of April, 2021. In mid-March all property owners will be receiving an Impact Notice in the mail that will have your Tentative Assessment for the 2021 Assessment Roll Year. There will be a cover letter included with this notice to detail information on your new assessment. I will be scheduling appointments late March through the first week in April for property owners that would like to discuss their new assessments. ****During the Revaluation Project my office hours will be Tuesday from 8:30 am - Noon** as I will be out in the field the remainder of the day reviewing properties.

Just a reminder that exemption time for the 2021 Assessment Roll is here. **Taxable Status Date is March 1st 2021.** Renewal exemptions for Senior Citizen, Disability, and Agricultural Exemptions will be mailed out in November. ALL renewal exemption applications must be submitted by March 1st, 2021. All other new exemptions need to be submitted to me by the Taxable Status Date, March 1st, 2021.

If you have recently purchased property you will be receiving a Residential Sale Verification Form in the mail. As part of our continuing effort to maintain accurate property records, we ask that you return it to my office as soon as possible.

New STaR Applicants need to register with the Department of Taxation and Finance. Website: www.tax.ny.gov/star or phone [518-457-2036](tel:518-457-2036) between the hours of 8:30 am - 4:30 pm.
