**A note from the Assessor.....**

Fall is upon us which means renewal exemption time is here for the 2022 Assessment Roll.

Taxable Status Date is March 1st, 2022.

Renewal exemptions for Senior Citizen, Disability, and Agricultural Exemptions will be mailed out in November. ALL renewal exemption applications must be submitted by March 1st, 2022.



All other new exemptions need to be submitted to me by the Taxable Status Date, March 1st, 2022.

If you have an address change, please contact me so that I can update your file. If you have recently purchased property you will be receiving a Residential Sale Verification Form in the mail. As part of our continuing effort to maintain accurate property records, we ask that you please complete the Residential Sale Verification Form and return it to my office as soon as possible.

New STaR Applicants need to register with the Department of Taxation and Finance. You may register on-line at [www.tax.ny.gov/star](http://www.tax.ny.gov/star) or by phone [518-457-2036](tel:518-457-2036) between the hours of 8:30am - 4:30pm.

The end of the state disaster emergency on June 24, 2021 ended the prohibition on penalties for delinquent water payments unless you have replied to the moratorium letter sent out with your 3<sup>rd</sup> quarter billing. To date only 1 person has replied an opted into a deferred payment plan. If you have NOT opted into a deferred payment plan and you have arrears on your water account, your account will be re-levied to Steuben County at the end of November, 2021.



All accounts to be re-levied will be sent a 30-day re-levy notice in October.

**RAFTING LOGS IN CAMPBELL  
200 YEARS AGO**

The first settlers in Campbelltown and Curtisville, in 1801, learned about the area by the example of the settlers in neighboring settlements. Early-on, they copied other settlers up-stream, who were using the Cohocton River's systems to transport logs and finished lumber in fleets down-stream to buyers. This system gave rise to sawmills in Campbelltown and Curtisville, which helped to develop the area.

Settlers were aware that the Cohocton River was a big asset for travel and that it is part of the Susquehanna River Basin. In those days it was navigable all the way to the Chesapeake Bay. Typically, to raft logs, they would use a crew of 6 to 10 watermen who would guide the rafts of logs through the Susquehanna's perils.

This required that the leader, called the pilot, would have knowledge of the dangers and how to direct the log rafts. A team of raftsmen would wait at points along the river to float a segment of the journey. When they got to a particular point, the team would pass their rafts along to another team of watermen and then walk back to the point of origin for the next day's run. In this way, millions of feet of lumber found its way down the Susquehanna during the 1800's.

In the later 1800's the supply of lumber was basically used up and the Town businessmen found other ways to earn a living.
