

**MINUTES OF TOWN BOARD PUBLIC HEARING
OF NOVEMBER 7, 2018
HELD AT THE TOWN HALL, 8529 MAIN ST., CAMPBELL, NEW YORK**

Pledge /Roll Call.

Mr. Horton led the pledge of allegiance. The Town Clerk then took roll call.

2019 Tax Cap Override—Public Hearing

Mr. Horton called the public hearing to order at 6:03 p.m. at the Campbell Town Hall in connection with the Tax Cap Override concerning the preliminary budget for 2019. It was noted that the legal notice was published in The Leader on November 1, 2018.

There was no public comment and Mr. Horton closed the public hearing at 6:05 p.m.

RESOLUTION #64-2018 was offered by John Tschantre and seconded by James Drumm as follows:

WHEREAS, at the Town Board meeting held October 15, 2018, the Town Clerk was directed to set a public hearing on the tentative Local Law #2 of 2018 as a local law to override the tax levy limit established in General Municipal Law Section 3-c, for the next regular meeting, which would be November 7, 2018 at 6:00 p.m. to hear all interested parties on a proposed local law entitled “Tax Cap Override Law”,

WHEREAS, a Notice of Public Hearing was duly advertised in The Leader on November 1, 2018, and notice was duly posted on the sign board in the Town Hall; and

WHEREAS, said public hearing was duly held on November 7th, 2018 at 6:00 p.m., with no public comment offered;

NOW THEREFORE, BE IT RESOLVED, that the Town Board hereby adopts said Local Law No. 2 of the Year 2018 entitled “Tax Cap Override Law”, a copy of which is attached hereto and made a part of this resolution, and

BE IT FURTHER RESOLVED, that the Town Clerk be and she hereby is directed to file same as Local Law #2 of 2018, to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town, and to give due notice of the adoption of said local law to the Secretary of State of New York.

2019 Preliminary Budget -- Public Hearing

Mr. Horton called the public hearing to order at 6:07 p.m. at the Campbell Town Hall in connection with the preliminary budget for 2019. It was noted that the legal notice was published in The Leader on November 1, 2018.

There was no public comment offered for or against the budget and the public hearing was then declared closed at 6:08 p.m.

Discussion was then had concerning the Bookkeeper's revisions and corrections to the preliminary budget. Wendy Oman, Bookkeeper, answered questions per the correction sheet [copy attached.]

It was noted that Fire Depts. #1 and 2 both submitted their budget requests on time and were both a part of the tentative and final proposed budgets. Fire #1 re-submitted their budget and the correct final amounts were listed on the Bookkeeper's correction sheet.

It was noted that there is an increase in over-all taxes from last year. The Town did the tax cap over-ride local law which will be filed on November 9, 2018 with the Department of State.

BUDGET- FY 2019

It was noted that the public hearing concerning the 2019 Preliminary Budget was held on November 7th with no public comment.

RESOLUTION #65-2018 was then offered by John Tschantre and seconded by James Drumm as follows:
