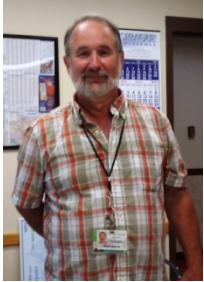

**WATER DEPARTMENT NEWS**

A new feature in our newsletter will be this new column for our water district residents. This quarter features information for:



**Water District #1**

Water #1 billing started June 2, 2008 with meters being installed in July 2008. The Bond was finalized in June 2009 as a 30 year principal only Bond at 0% interest. Water billing postcards are mailed monthly.

Your water bill breakdown on your billing postcard is as follows: For those connected to the water system - WTR is your monthly water usage figure, up to 9000 gallons (additional fees apply when you go over 9000), of \$13.97. For those not hooked to the water system your WTR is \$4.08. Everyone in District #1 also pays the WOT figure of \$33.00 per month for the Bond payment. WAR is the water arrears figure for any past due water bill. There is a 3.5% monthly penalty for unpaid bills plus an additional \$10 per month if no payment is made for 2 consecutive months. Water bills over \$99.99 are sent to the County annually for re-levy onto your

Town and County Tax bill. Any questions give me call.
