Resolution # 3 of 2022 was introduced by Glenn Vogel and seconded by James Drumm
BE IT RESOLVED, that the Town Board be and hereby establishes the following as a standard
work day for elected and appointed officials for the purpose of determining days worked
reportable to the NYS and Local Employees' Retirement System:

ALL ELECTED OFFICIALS—Supervisor; Councilperson; Town Clerk; Tax Collector and
Town Justice—Five day work week; six hour day.

Superintendent of Highways—Five day work week, eight hour day.

APPOINTED OFFICIALS-- Code Enforcement Officer; Dog Control Officer; Assessor.—
Five day work week, six hour day.
